Appendix A: Faculty Senate Executive Committee Report

On May 7, 2024, the Faculty Senate Executive Committee met with the provost. As mentioned earlier, Faculty Senate will be meeting in person. I should note that Senate falls under the Open Meetings Law, which states that only those with a qualified disability or an emergency will be able to access a special zoom link. All others will need to be in person. The curriculum committees will be meeting in person starting in September.

The provost noted that the administration has already started to reach out to those in the education and health sciences schools in order to discuss what new structure might result from a possible merger or other change.

There was a general discussion about the Freshman Year Experience. The provost noted that one third of the freshman class leaves, something he wants to prevent. The plan is to come up with coordinated services that provide a sense of belonging. These will include advisement and other services. We talked about how the needs of both AA and BA students could be met.

The provost stated that St. George continues to run on a two day schedule and, at the time of the meeting, the college was still looking for a sub-lessee.

There was a discussion about the departmental ceremonies of HSS departments, including about actions taken to make sure that students felt special.

We raised the problem of the CUNY Macaulay commencement being scheduled opposite CSI's commencement. The provost stated that he was aware it wasn't fair to CSI students in Macaulay Honors and that he had made his displeasure known.
